Inappropriate behavior will not be tolerated. 7 Lazy P Outfitting, LLC may terminate an individual's hunt and remove them from the premises if inappropriate behavior, including vulgar language, become disruptive to the camp and others. If you choose to bring alcohol, bring *canned* beer, *boxed* wine, or liquor in a *plastic* container.

Payment
